- Pay for any damage, willful or otherwise, (including abuse of such property) caused by our child(ren).
- Ensure that all accounts are current; **accounts that are in arrears are not eligible for the discounted fees.**
- Ensure that lunch money will be placed on the family account regularly, if applicable, and will not incur a negative balance. Otherwise my child(ren) will not be allowed to charge lunch.
- Meet financial agreements **on or before the due date for all fees.**

- The school may withdraw my child(ren) from classes on or after the last day of the month, if fees are not paid.
- The school may withhold and refuse to release transcripts, records, references or other information (except for details of the amounts owing) until all accounts, including tuition fees, late fees, book fees, fines, bookstore charges, etc. are paid in full.
- I am obligated to pay the fees for every day my child is enrolled whether he/she is in attendance or not.
- I will have to pay a \$25 fee if any of my checks to the school is returned unpaid by my bank.
- The school may change the status of the financial agreement if payments are not upheld accordingly.
- Except for extenuating circumstances the status of my financial agreement will remain the unchanged.
